

## Acceptable forms of ID for Online Registration

To register as a Brunel Student you will be requested to upload:

### A current valid passport

(If you do not have a valid passport, please see the alternative ID which we accept below)

#### Alternative Acceptable Photo ID

Please provide documents from one of the following options:

- Current valid UK biometric residence permit (BRP)
- Current valid UK or EEA photo driving licence **AND** a British birth certificate
- Current valid UK or EEA photo driving licence **AND** a current SLC Funding letter confirming funding
- Current valid UK or EEA photo driving licence **AND** 4 other forms of identification listed in the table below
- Brunel University London Student ID photo card (if you are a recent former Brunel student)
- Expired UK passport: which expired less than a year before the registration date and the person in the picture is an adult; **OR** which expired more than a year before the registration date / the person in the picture is a child **AND** a British birth certificate or other valid form of photo ID from the list below

If you are unable to provide us with any of the photo ID documents listed above, please contact the Admissions Office (+44 (0)1895 265 265 or [registration@brunel.ac.uk](mailto:registration@brunel.ac.uk)) to discuss your situation and the alternative forms of ID which can be accepted. This would normally be **at least 5** official documents listed in the table below.

| Mortgage statement   | UK or EEA                           | Issued in last 12 months             |
| Bank or building society statement                           | UK, Channel Islands or EEA          | Issued in last 3 months              |
| Bank or building society account opening confirmation letter | UK                                  | Must still be valid                  |

| Financial statement<br>e.g. pension or endowment   | UK   | Issued in last 12 months |

| Council Tax statement  | UK and Channel Islands   | Issued in last 12 months |
| Immigration document, work permit or visa  | UK   | Must be valid            |
| Utility bill (excluding mobile telephone bills)  | UK   | Issued in last 3 months  |
| Benefit statement e.g. Child Benefit, Pension  | UK   | Issued in last 3 months  |
| Central or local government, government agency or local council document giving entitlement e.g. from the Department for Work and Pensions, the Employment Service, HMRC | UK and Channel Islands   | Issued in last 3 months  |
| EEA National ID card   | EEA  | Must still be valid      |
| Cards carrying the PASS accreditation logo   | UK, Isle of Man and Channel Islands  | Must still be valid      |
| Letter from Head Teacher or College Principal  | UK - for 16-19 year olds in full time education<br><br><i>(only used in exceptional circumstances if other documents cannot be provided)</i> | Must still be valid      |
